## ***CORPORATE MEMBERSHIP INFORMATION***

The number of Corporate Memberships available in a given year will be determined by the Board of Governors and may be amended at any time without notification.

The Company must be registered under the laws of Manitoba or in another province of Canada.

The Company must be approved by the Membership Committee, and if deemed necessary by the Committee, the Board of Governors of Elmhurst.

The Company must have a minimum of four employees on its payroll. A maximum of four designated employees must be listed on the Corporate application.

Includes the use of one locker, shoe cleaning for one pair of shoes, golf club storage and cleaning for one set of clubs. Additional locker and club storage may be obtained at the cost of \$50.00 and \$120.00 respectively.

A Food and Beverage Assessment of \$600.00 per Corporate Membership will be levied. The Assessment may be imposed against the master Corporate Account or against individual members' accounts. This should be decided prior to the beginning of the golf season, and the Club Office should be notified of the decision of the Corporate members.

Members and their guests must abide by the rules (including Dress Code policy) of Elmhurst Golf and Country Club.

Signing privileges for the dining facility and/or Pro Shop must be designated at the start of the golf season. A list of Corporate signers may be kept in the Dining Room or Pro Shop.

Payment of yearly fees is due in full by March 31<sup>st</sup> of the year of membership. Payment for purchases and services are payable on receipt of the monthly statement. The current Elmhurst credit policies apply. Credit Card required for individual account members.

***There is:*** No share purchase required.  
No voting privilege included with this membership category.

## ***CORPORATE MEMBERSHIPS***

### ***Regarding tee times and bookings:***

- Tee times are unrestricted, with the following caveat: that during prime tee times on Saturday, Sunday and holidays (meaning prior to 1:00 PM) only one (1) guest per foursome is permitted. Anyone not included on the list of four (4) members constitutes a guest.
- One of the named employees may bring out or sponsor up to three (3) guests for a round of golf. The Corporate Member's guests' golf game may be included as a game of the Corporate Member's golf game package; or can be assessed at the current guest green fee level. This may be charged in the Pro Shop, paid in cash or charged to a credit card in the Pro Shop.
- No more than one foursome of a Company's group will be allowed on the course at any given time unless approved by the Club Manager.  
Corporate tickets must be used in the season that they are issued.  
A round of nine or more golf holes played constitutes a round of golf played. There are no partial rounds played.

Special green fee packages are not available for purchase by the Corporate Members.

### ***Corporate Members are entitled to:***

- Join the Golf Range and the privilege of this membership.
- Purchase golf cart packages.
- Golf and Dinner Package specials for guests or spouses.
- Play in Club tournaments and events so long as they count that round as a round of golf played.

***Fees for 2005 are \$3,878.50 + 271.50 GST for a total of \$4,150.00.  
This entitles each Company to a package of ninety (90) rounds of golf.***

***Food & Beverage Assessment = \$600.00***

***A \$10.00 administration fee will be applied to all requests for statement information (ie. retrieval of expense chits) by individual employees or corporate accounts.***

## DRESS CODE

Appropriate attire is required both on the course and in the clubhouse. If in doubt, consult the Club Professional or the Pro Shop staff, or the Club Office. Please remember that technically the Dress Code is in effect when you enter through the gate onto Elmhurst grounds.

### GOLF COURSE

**MEN** Shirts with collars and sleeves, slacks or golf shirts are appropriate. Unacceptable are T-shirts, tank tops, fishnet tops, blue jeans, sweat pants, cut-offs, bathing suits, tennis or other brief athletic shorts.

**WOMEN** Dresses, skirts, slacks, golf shorts and blouses are appropriate. Unacceptable are tee-shirts, halter tops, fishnet tops, blue jeans, sweat pants, cut-offs, bathing suits, tennis dresses or other brief athletic shorts.

**SHOES** Golf shoes are preferred. Acceptable are light tread running shoes. Unacceptable are dress shoes and athletic shoes, with studded or rugged soles because of damage to tees and greens.

**ONLY SOFT SPIKE SHOES WILL BE ALLOWED ON THE COURSE.** If there are any questions, please contact the Club for further information.

**CLUBHOUSE** Spikeless shoes may be worn on the upstairs carpet. No stocking feet in lounge or dining area.

Dress worn by members in the clubhouse should at all times conform to the accepted practice of all good clubs.

**NO HATS** allowed upstairs.
