GENERAL INFORMATION

1. Two (2) shareholders in good standing must sponsor new members. In the event that a prospective member does not have a sponsor, the Board may provide authorization. All memberships are to be approved by the Board.
2. A birth certificate is required for membership in age category groups.
3. A time payment plan is available for membership dues for all members except those in the Corporate, Clubhouse, Junior and Junior Youth categories. Please see "Time Payment Arrangement for Membership Dues".
4. All 2005 dues are plus GST.
5. The cost of a Share for Active members is \$600 (plus GST) and the Transfer Fee is \$2,500 (plus GST) for a total of \$3,317.00
The Share cost for Associate members is \$600 (plus GST) and the Transfer Fee is dependent on age (please refer to "Associate Payment Plan").
6. A time payment plan is available for new members purchasing a share. Please see "Time Payment Arrangement for Share & Transfer Fees".
7. Shares may be transferred to family members as a one-time option, upon written request. Share redemption is available but not on demand -- a waiting list shall occur if there are more requests for share redemption than shares being purchased.
8. Refund requests for Membership suspensions due to ill health shall be in accordance with the existing Medical Refund Policy.
9. A Food and Beverage Assessment of \$300 will be levied to each active member. This assessment is not applicable to House, Intermediate, Junior or Junior Youth categories.
10. **PLEASE NOTE:** The Dress Code policy is in effect for all members of Elmhurst Golf & Country Club, as well as their guests. Dress worn in our Clubhouse should at all times conform to the accepted practice at all good clubs. **Blue jeans are not allowed anywhere at Elmhurst.**

WOMEN Dresses, skirts, slacks, golf shorts and blouses are appropriate. Unacceptable are tee-shirts, halter tops, fishnet tops, blue jeans, sweat pants, cut-offs, bathing suits, tennis dresses or other brief athletic shorts.

SHOES Golf shoes are preferred. Acceptable are light tread running shoes. Unacceptable are dress shoes and athletic shoes, with studded or rugged soles because of damage to tees and greens.

CLUBHOUSE Spikeless shoes may be worn on the upstairs carpet. No stocking feet in lounge or dining area.
